LIABILITY RELEASE FOR SCUBA DIVING ACTIVITIES

1. I understand the purpose of signing this document is to exempt FRP, LLC and/or owners, members, relatives and release its agents, employees, contractors and its equipment and fixtures and to hold these entities harmless from any and all liabilities arising as a consequence of the following or any acts or omissions on their part, including but not limited to negligence.
2. I am a certified diver, or a student diver under the direct supervision of an instructor, and have been taught that SCUBA diving has inherent risks and dangers associated therewith; including, but not limited to, risks associated with equipment failure, perils of quarry diving and/or acts of fellow divers and I specifically assume such risks.
3. I have been diving within the past year, am currently in a refresher course or I am currently participating in an open water diving course with a qualified instructor.
4. I acknowledge that I am physically fit for a SCUBA dive and snorkel, and I will not hold anyone responsible if I am injured as a result of heart problems, lung problems, or other illness or medical condition which may occur while diving and/or snorkeling.
5. I do not have in my possession any illegal drugs, nor am I taking, nor have I recently consumed any drugs or medications that may contradict my diving abilities. I am not under the influence of alcohol, nor am I hung over. I also agree not to bring any firearms, weapons, spear guns of any type onto the premises.
6. Prior to entering the water, I will inspect all equipment. If any of the equipment is not functioning properly, I will not enter the water.
7. I will be present and attentive to any safety briefing given by my instructor, and if there is anything I do not understand, I will notify my instructor immediately.
8. I understand that I have a duty to plan and carry out my own dive and to be responsible for my own safety, and for my buddy, and others, I will remain with my buddy at all times. I will be aware of my surroundings, in and out of the water at all times.
9. I will start my ascent at the end of each dive with enough air to guarantee exiting the water with a minimum of 500 psi remaining in my tank.
10. I will immediately stop my dive if I feel uncomfortable with my diving abilities and/or diving conditions are worse than those for which I have been trained or have experience. If I become distressed at any time, I will give the proper "Diver in Trouble" signal.
11. I am aware of the dangers of holding my breath while diving and of the dangers associated with rapid ascents, and I am responsible for myself. I am aware that quarries may pose hazards from falling rocks, high cliffs, unstable wall sides and/or gravel piles in and out of water. I am also aware there are no handrails around the lake.
12. I am fully aware that FRP, LLC has no medical facilities. In the event of illness or injury, appropriate medical help must be summonsed and that the treatment may

- be delayed until medical emergency responder arrives on scene and I can be transported to a proper medical facility.
13. There is no swimming allowed (must have a float if not diving), no fishing/spearfishing. Our fish are here for enjoyment only. You may feed them fish/dog food.
 14. I am aware that FRP, LLC is open for other activities as well and I am aware that people do jump in the water from the edge, the floating docks, and/or their rafts. I will stay deep enough in the water so that other guests/floaters do not interfere with my diving activities.
 15. It is my intention, by signing this document, to give up any right to sue all persons or entities referred to herein whether specifically named or not. It is my intention to exempt and relieve any and all persons, entities, facilities, equipment and fixtures and to hold these entities harmless from any and all liability for personal injury, property damage or wrongful death caused by negligence, and I assume all risk in connection with snorkeling and all other activities, in and out of the water.
 16. I have read and understand the foregoing document in its entirety and agree to the terms and conditions hereinabove set forth on behalf of myself, heirs and my personal representatives.
