FRP-LaGrange Quarry

Release of Liability

____ 1. I understand the purpose of signing this document is to exempt, FRP LLC, LaGrange Quarry and/or owners, members/relatives and release its agents, employees, staff and its equipment and fixtures and to hold these entities harmless from any and all liabilities arising or any acts or omissions on their part, including but not limited to negligence. I am at my own risk. This is a rock quarry; not a state park. Please be aware of all surroundings.

____ 2. I understand that FRP is a DRUG/ALCOHOL FREE ZONE. I also agree that I am not taking, or recently consumed any drugs/alcohol, medications that may contradict my abilities. I am not hungover. I do not have any illness that may lead to injury.

____ 3. I understand FRP has the right to search my vehicle, bags, coolers and other belongings. By signing, I consent to having myself, my vehicle, and any property searched. If I refuse, I have to leave the premises without a refund.

____ 4. I am aware that I am in a deep open pit rock quarry. I am aware that quarries may pose hazards from unsafe footing, from falling rocks, high cliffs, unstable walls, in and out of the water. I am aware of all dangers. I will not climb any rock wall in or out of the water. I will not climb up the island walls. I will use the red ladders or beach areas when exiting the water.

____ 5. I am fully aware that FRP has no medical facilities or medically trained staff. In the event of illness or injury, appropriate medical help must be summonsed and treatment will be delayed until medical emergency responders arrive on scene and I can be transported to a medical facility. I am responsible for any medical charges. I agree to file an accident report with FRP before leaving the property.

____ 6. I am aware that NO SWIMMING is allowed. I must have a floatation device with me at all times in the water. I do understand that there is no lifeguard on duty and that I am solely responsible for my personal safety at all times. If I do not know how to swim, I will stay out of the water and away from the edges.

____ 7. I am fully responsible for all personal belongings. Please keep cars locked at all times. Park in designated areas only.

____ 8. I understand that while at FRP, I may be subject to being recorded by such devices as drones, go pro cameras, security cameras, etc. as these are allowed to be used at FRP and we cannot control when and where these pictures or videos may be used.

____ 9. Pets/Animals of any type are not allowed on the property. No fishing allowed. No spearguns allowed.

____ 10. I agree to remain on my best behavior and follow all rules. If at any time, I am asked to leave the park, a refund will not be given and I will be banned for the season. We have a zero tolerance for disrespect of any kind.

____ 11. I am aware of the CDC guidelines and agree to abide by them while at FRP. I do not have any Covid 19 symptoms, nor, to my knowledge, have I been around anyone with the virus. Please use social distancing. Limit group sizes.

____ 12. I have read and understand the foregoing document in its entirety and agree to the terms and conditions hereinabove set forth on behalf of myself, my heirs and my personal representatives. I agree that I am 18 years of age or older with a current Govt Issued ID and I agree that all the information below is accurate and the most recent.
